With reference to your Application on the subject cited above, approval for the approachion of the existing Middle School to Secondary level is granted with effect from 1984-85 Session subject to the fulfilment of the following terms and conditions:-

- That the school shall abide by the provision of Delhi School Education Act to Rules framed thereunder as well as the instructions i sued from time to time.

That the enrolment in section shall not exceed the number of students calculated @ 12 sq. ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation, as per the Horms of the Directorate of Education. Delhi in each class. Humber of sections should not exceed the number of existing class-rooms of proper size in the school.

- 10. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
